GALVESTON COUNTY EMERGENCY SERVICES DISTRICT NO. 2**

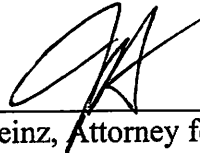

Notice is hereby given that a Regular Meeting of the Board of Commissioners of the Galveston County Emergency Services District No. 2 will be held on August 16, 2017, beginning at 3:00 p.m., at the Crystal Beach VFD Fire Station, located at 930 Noble Carl Road, Crystal Beach, Texas 77650, for the following purposes:

Regular Meeting

1. Call to order.
2. Determination of quorum.
3. Pledges of Allegiance to the U.S. and Texas flags.
4. Public comment. In accordance with the Texas Attorney General’s opinion, any public comment that is made on an item that is not on the published final agenda will only be heard by the Board of Commissioners. No formal action, discussion, deliberation, nor comment will be made by the Board of Commissioners.
5. Chiefs and Director’s reports on monthly activities of the VFDs and PEMSI; review reports/information submitted by VFDs and PEMSI.
6. Review and approve minutes of the following meetings:
 - July 19, 2017 regular meeting; and,
 - August 3, 2017 budget workshop and special meeting.
7. Treasurer’s report on District’s finances, and review and consider any proposed 2016-17 budget amendments.
8. Discuss and take action to approve and authorize payment of the District’s bills and accounts, along with PEMSI and the VFDs’ expenditure reimbursement requests.
9. Review, discuss, and take any needed action regarding asset/equipment purchases and repairs, including, but not limited to, proposals being submitted by and/or obtained for PEMSI and/or the VFDs.
10. Review and discuss District and departments’ proposed 2017-18 budgets, and take action on District’s *proposed* 2017-18 budget by record vote.

11. Discuss and take action on establishment of District's *proposed* 2017 tax rate by record vote, as well as scheduling and announcing of two public hearings concerning proposed tax rate increase and meeting at which Board will vote to adopt the District's 2017 tax rate, and the publication of required notices in the newspaper and on the District's website.
12. Review, discuss and take action on personnel policy for the District.
13. Discuss and take any needed action in relation to District Manager position.
14. Review, discuss and take any needed action concerning proposed creation of Gilchrist Volunteer Fire Department.
15. Review, discuss and take any needed action regarding the records and information produced by PEMSI in response to the Board's July 19, 2017 record request, as well as PEMSI's service agreement and overall operations.
16. Accountant report.
17. Counsel report.
18. Such other matters that may come before the board.
