 7. Review and discuss draft 2020-21 budget and take any necessary action in relation to same, and discuss timeline for adopting the District's 2020-21 budget and setting the 2020 property tax rate.
 8. Review and take action to authorize and approve interlocal agreement with BuyBoard purchasing cooperative.
 9. Discuss and take action to declare 5" supply hose as surplus property and authorize sale of same to local VFD.
 10. Discuss and take action to declare exercise equipment (elliptical and rowing machine) and air bag (J.T. Scurlock Safety Products Ac-70 Safety Air Cushion) as surplus property and authorize sale of same through Rene Bates online auction.
 11. Discuss and take any need action concerning matters related to the COVID-19 outbreak, including, but not limited to, the District and EMS's procedures and protocols put in place as a result of same.
