Regular Meeting

5. Review, discuss and take action on District’s 2019-20 Audit Report, and submittal of same to the Galveston County Commissioners Court in accordance with Section 775.082 of the Texas Health & Safety Code.

All items will be acted upon by one vote without being discussed separately unless requested by a Board member. Any item requested to be discussed separately will immediately be withdrawn for individual consideration in sequence after the remaining items have been acted upon.
