Notice is hereby given that a Special Meeting of the Board of Commissioners of the Galveston County Emergency Services District No. 2 will be held on August 9, 2023, beginning at 12:00 p.m., at the Crystal Beach VFD Fire Station, located at 930 Noble Carl Dr., Crystal Beach, Texas 77650, for the following purposes:

Special Meeting

1. Call to order.
2. Determination of quorum.
3. Pledges to the U.S. and Texas flags.
4. Public comment. In accordance with the Texas Attorney General’s opinion, any public comment that is made on an item that is not on the published final agenda will only be heard by the Board of Commissioners. No formal action, discussion, deliberation, nor comment will be made by the Board of Commissioners.
5. Review, discuss and take action to accept and approve the District’s 2023 Certified Appraisal Roll prepared and provided by the Galveston Central Appraisal District and the District’s 2023 Tax Rate Calculation Worksheet prepared and provided by the Galveston County Tax Assessor/Collector, and authorize posting of same on the District’s website.
6. Review and discuss the District’s fiscal year 2023-24 budget, and take action to approve the District’s *proposed* 2023-24 budget by record vote.
7. Discuss and take action to approve the District’s *proposed* 2023 property tax rate by record vote, and, if necessary, schedule and announce a public hearing concerning proposed tax rate increase and meeting at which Board will vote to adopt the District’s 2023 property tax rate and authorize publication/posting of required notices in the newspaper and on the District’s website.
8. Such other matters that may come before the board.
9. Adjourn.
