Notice is hereby given that a Regular Meeting of the Board of Commissioners of the Galveston County Emergency Services District No. 2 will be held on August 20, 2025, beginning at 12:00 p.m., at the Crystal Beach fire station, located at 930 Noble Carl Dr., Crystal Beach, Texas 77650, for the following purposes:

Regular Meeting

1. Call to order.
2. Determination of quorum.

4. Public comment. In accordance with the Texas Attorney General's opinion, any public comment that is made on an item that is not on the published final agenda will only be heard by the Board of Commissioners. No formal action, discussion, deliberation, nor comment will be made by the Board of Commissioners.
5. Review and discuss upcoming schedule and other matters relating to the District's FY 2025-26 budget and 2025 property tax rate. Announce date/time/location of the the public hearing concerning and the regular meeting at which the Board will take action to adopt the 2025 property tax rate.
6. Consent Agenda

The following items are of a routine or administrative nature. The Board has been furnished with background and support material on each item. All items will be acted upon by one vote without being discussed separately unless requested by a Board member. Any item requested to be discussed separately will immediately be withdrawn for individual consideration in sequence after the remaining items have been acted upon.

- b. Payment of District's bills and accounts; and,
- c. Payment of VFDs' monthly reimbursement requests.

7. Receipt, review, and take any needed action regarding the Treasurer's Report, and take action on any proposed budget amendments and/or account fund transfers.
8. Review, discuss, and take action on expenditure requests/capital purchases, including, but not limited to, High Island VFD's recent Polaris ATV purchase, and Port Bolivar VFD's notice of intent to pour a 40' x 40' concrete slab for use as helicopter landing pad.
9. Review, discuss and take any needed action regarding the District's Manager's employment contract and annual performance review.
10. Discuss and take action to authorize District Manager's participation in Emergency Medical Task Force 6 (EMTF6 in cooperation with Southeast Texas Regional Advisory Council) to support Texas Ambulance Strike Team upon request.
11. Discuss and take action to appoint a Board member to serve on the District Employee Health Insurance committee.
